Notices were placed in print media and social media as well as the Credit Union's website inviting members to submit applications for the committees of their choice. The nomination period was January 29th – February 15th 2021 and it was further extended to February 22nd 2021 to allow persons who had indicated a willingness to serve but was unable to submit their applications by February 15th, 2021 to do so. Nominations forms outlining the criteria for nominees were posted online and were available in our offices.

The Committee approached the Board requesting an extension of the nomination period to February 22nd, 2021. Nominations closed on February 22nd, 2021. The Committee received twenty-five applications which were reviewed based on the criteria outlined on the nomination form and in accordance with the election of officers stated in the Credit Union's Bye Laws. Twenty-two applicants met the requirements, and three applicants who did not meet the requirements were so informed. The Committee forwarded their recommendations to the Board and the successful persons were invited to attend an orientation training on March 6th, 2021 via Zoom.
